State of the School

COO Report (6:30 PM - 6:50 PM)

- Enrollment Update (recruitment tab)
 - o SY24-25: 435 applications so far
 - The enrollment max is 645 (excluding pre-K). This is the most FTE we would get reimbursed for
 - March is the big push, 3 tours a month
 - Elementary school tour yesterday
 - Middle School tour last week
 - A new Second grader is joining next semester!
 - Send a thank you message to the person who referred the student
 - ²/₃ of applications are coming from District 5
 - Add a new grade & district chart for current enrollees
 - Having this info will benefit recruitment
 - The Tenants Association has requested to host their meetings at the Elementary School – more to come
- Fundraising Update
 - Big Shout-Out to Ibrahim- He has raised over \$3k, almost all donations from Deloitte employees
 - Bloomberg announced that they will be supporting the Summer Program again!
 - Up to \$2k per student
 - Bill has signed up for the information sessions
 - After-school programming is most likely lowest lowest-hanging fruit to receiving funding
 - Charter Center has asked that they pen an Op-ED (NY Post) about security guard funding.
 - Right now there are funds for private and religious schools but not for charter schools. Charter School advocacy push
